Dear Principal,

Kindly refer to the Council's letter dated 26.10.2020 through which a clarification regarding physical reporting of newly admitted students was communicated. In the meantime Ministry of Home Affairs, Govt. of India has issued Guidelines and through which all the Guidelines of Unlock-5 have been extended till 30th November, 2020. Accordingly the matter of physical reporting has further been discussed at the appropriate level in the Council and decided that earlier communicated tentative date of physical reporting should be postponed from 2nd November, 2020. It has further been suggested by the appropriate authority of Council that physical academic activities shall therefore be remained suspended till the effect of Unlock guidelines issued by MHA, Govt of India. The matter will further be reviewed on 30th November, 2020 on the basis of revised guidelines, if any, for Unlock-6 and accordingly a tentative date of physical reporting will be communicated to all the Institutes. However, the on-line classes should be continued as suggested earlier.

It is further requested that in case any Institute has already decided about the date of physical reporting before 30th November, 2020, may please postpone the same.
