In partial modification of para 3 of this Ministry's letter no. 72(11)/2007-HRD dated 17.02.2009, the qualifications, experience, emoluments etc. of Teaching Associates appointed in contract basis by Central Institutes of Hotel Management will be as under with immediate effect:

Sl.No.	Designation	Qualification & Experience	Emoluments
1	Teaching Associates	Full time Bachelor's Degree in Hospitality & Hotel Administration / Hotel Management after 10+2 from a Recognized University and full time Master's degree in Hospitality & Hotel Administration / Hotel Management securing not less than 60% marks in aggregate either in bachelors or master's degree. OR Full time Bachelor's Degree in Hospitality & Hotel Administration / Hotel Management after 10+2 from a Recognized University securing not less than 60% marks in aggregate with at least 2 year industry experience.	Rs. 25,000/- per month with annual increment of Rs. 1,000/- limited to 2 increments

2. The above recommendations may be placed before the Board of Governors of the respective IHMs as required under the Rules and Regulations of the Society for consideration and approval before implementation.

3. The additional expenditure involved in the above enhancement of emoluments of Teaching Associates would be met by the Institutes from their own income and this Ministry will not extend any grant in this regard.

CIRCULAR

The Board of Governors of NCHMCT, in exercising the power vested under Clause (a) of Section 30 of the Memorandum of Association and Rules & Regulations of the Council, made an addendum in the NHTET Scheme during its 47th meeting held on 26th October 2018 vide item 47.10. The addendum is basically the process to be adopted during final selection of Assistant Lecturer and Teaching Associate in the Institute under direct recruitment, after the candidates have qualified with NHTET exam with required pass percentage. The entire addendum to the NHTET scheme i.e. procedure for final selection - by conducting practical skill tests and teaching skill test is attached herewith for implementation by the affiliated IHMs (sponsored by central government, state government, PSU and private), in its true spirit. As such, the institute will not be allowed to make their own system of conducting skill tests for final selection towards maintaining uniformity in selection, to make justice to the NHTET qualified candidates and to bring quality in hospitality education. This scheme is effective from any selection process to be held from the date of issue of this Circular and onwards.

Compliance of the scheme may please be intimated to the Council.
